Standard Cabin & Deluxe Park Model Rental Agreement

RATES: Standard Cabin and Deluxe Park Model rates are at quoted price, plus Morrow County Sales Tax.

RESERVATIONS: To confirm your reservations, we require this signed rental contract along with check or credit card payment of one night's stay, in order to secure your dates. Tentative reservations will be held for 10 days awaiting arrival of this form and payment in the mail. We accept cash, checks or credit card payments of balance due, upon your arrival.

CANCELLATION: If you cancel more than 10 days prior to your arrival, you will not be charged. However, if you cancel less than 10 days prior to your arrival, your deposit of one night's stay may be forfeited. If you re-book a different date, your deposit may be transferred over to the new date, at the discretion of management.

AVAILABILITY: Sometimes acts of nature and other forces beyond our control prevent a cabin from being rented as reserved. Therefore, we reserve the right to substitute another cabin that we consider equivalent to the cabin that was reserved. We will attempt to contact you in advance of any such changes.

CAPACITY: The capacity of each standard cabin or deluxe park model is 4 people, maximum of 2 adults. Additional adults will be charged \$10 each, per day; additional children \$5 each, per day. Exceptions will only be made at the discretion of management. Standard cabins have one bedroom with a full size bed, plus a pull out sleeper sofa in the living room area. Deluxe Park Models have one bedroom with a queen size bed or bunk bed, plus a pull out sleeper sofa in the living room area. Bathrooms in all models have a shower, toilet and sink. Kitchens in all models have a sink, refrigerator, microwave and coffee pot (deluxe models also have toasters).

LINENS: You must provide all bedding linens and pillows, as well as towels and washcloths.

UTENSILS: A small selection of cooking utensils is provided, however you are responsible for providing all cookware, dishes & flatware that you may need during your stay. Disposable products are recommended. A charcoal grill is provided, but must be moved away from cabin and deck to gravel or grass area during use. You must furnish your own charcoal and lighter fluid.

CONSUMABLES: We provide a limited supply of items such as toilet paper, paper towels and dish soap. You should however, plan to bring any personal soaps needed during your stay. (For extended stays of 3 days or more, you might consider bringing extra paper towels, tissues, etc.)

UTILITIES: All models have air conditioning and heat. When leaving for the day, please turn off lights and televisions, and make sure windows are closed in case of inclement weather or if heat/air is being run.

SMOKING/PETS: Smoking is not permitted inside the cabins. No pets inside cabins, please. Fireworks are prohibited.

CHECK IN/CHECK OUT: Check in time is 1:00 p.m. on day of arrival, unless earlier time is approved by management. Please have all items removed by check out time of 11:00 a.m. day of departure, unless a later time is approved. Trash should be placed in dumpster outside upon departure. Your cabin will be clean upon your arrival, and cleaned again after your departure. Please observe inventory check list for all models, and make sure all coffee pots and utensils are washed and clean upon departure.

DAMAGE: All models are inspected and cleaned following each occupancy. You are responsible for any damages or missing items incurred during your stay. You will be billed for any damage or missing items upon your departure.

We, the undersigned, hereby understand and agree to all the terms of this agreement. Failure to uphold any provision of this agreement may result in eviction of premises.

We also agree to comply with all of the campground rules and regulations.

Furthermore, we understand that we will be held accountable for any and all damages to campground property incurred by ourselves, family members, or our visitors.

We, as guests, do hereby release Cardinal Center, its officers and employees, of all liability for loss or damage to our property, as well as any injuries that may arise out of the use of this camping facility.
